- Compliance with Masimba's key requirements.
- Integration capabilities with Masimba's existing and third-party systems and technology infrastructure.
- Data migration strategy.

# 4.4 Implementation Approach

- Proposed project timeline (discovery, configuration, testing, go-live).
- Change management and training support.

## 4.5 Pricing and Licensing Model

- ERP licensing structure (per user, subscription, one-time fee).
- Estimated costs for project implementation.
- Ongoing maintenance and support fees, where applicable.

# 4.6 Vendor Support and Service Level Agreement (SLA)

- Project pre- and post-implementation support model.
- SLAs for issue resolution.
